

# This is the last Will of me

AMY DYKES of 173 Gorsey Lane Warrington Cheshire Spinster

which I make this fifteenth day of November  
one thousand nine hundred and eighty four.

1. I HEREBY REVOKE all former Wills and testamentary

dispositions made by me and declare this to be my last Will

2. I APPOINT my cousins Olive Morris of 54 Babbacombe Road

Penketh Warrington aforesaid, and Michael Roy Bennett of 2 Susan Drive Penketh aforesaid (hereinafter called "my Trustees") to be the Executors and Trustees of this my Will

3. I GIVE the following legacies (free of capital transfer tax) namely:—

(a) To my said cousin Olive Morris the sum of One hundred pounds if she shall prove this my Will and act in the trusts hereof

(b) To my said cousin Michael Roy Bennett the sum of One hundred pounds if he shall prove this my Will and act in the trusts hereof

4. I GIVE DEVISE AND BEQUEATH all my real and personal property whatsoever and wheresoever to which I may be entitled or over which I have any disposing power at the time of my death not otherwise disposed of by this my Will or any Codicil hereto unto my Trustees upon trust to sell the same with power to postpone sale for such period as they shall in their absolute discretion think fit without being liable for loss and out of the proceeds of sale and my ready money to pay my funeral and testamentary expenses and debts including any capital transfer tax payable on or by reason of my death and to stand possessed of the residue thereof and the investments for the time being representing the same and such part of my estate as shall for the time being remain unsold upon trust for such of my following cousins as shall be living at my death and if more than one in equal shares namely Jack Bennett the said Olive Morris Frank Brian Bennett

Evelyn Mavis Gandy Edward Hugh Bennett-David Bennett and the said Michael Roy Bennett PROVIDED that:-

- (a) If any of my said cousins (other than the said Edward Hugh Bennett) shall have died during my lifetime leaving a child or children living at the date of my death then such child or children shall take and if more than one in equal shares per stirpes such part of my residuary estate as his her or their parent would have taken had he or she survived me and attained a vested interest \_\_\_\_\_
- (b) If my said cousin Edward Hugh Bennett shall have died during my lifetime then I direct that the share of my residuary estate which my said cousin Edward Hugh Bennett would have taken had he survived me shall be held by my Trustees for his son John Bennett absolutely if he shall have survived me - - - - -

5. IF the trusts of any such share shall fail or determine then as from the date of such failure or determination such share and any share which may accrue thereto by virtue of this provision shall be held by my Trustees as an accretion to the other share or shares (and equally if more than one) the trusts of which shall not at the date of such accruer have failed or determined and upon the trusts powers and provisions applicable thereto herein contained or such of them as at the date of such accruer shall be capable of taking effect \_\_\_\_\_

6. I DECLARE that trust moneys may be invested in the purchase of or in lending upon the security of such stocks funds shares securities or other investments of whatsoever nature and wheresoever as my Trustees shall in/their absolute discretion think fit to the intent that my Trustees shall have the same free and unrestricted powers of investing and transposing investments as if they were absolutely and beneficially entitled thereto \_\_\_\_\_
