THIS IS THE LAST WILL AND TESTAMENT

of me **KATHLEEN THOMPSTONE** of 13 Pine Road Macclesfield Cheshire SK10 1QD
Widow

1. **I REVOKE** all former testamentary dispositions
2. (a) **I APPOINT** as my Executors and Trustees: **WILLIAM OGDEN** of 63 Adshall Road Cheadle Cheshire and **PETER WHITTAKER** and his wife **CYNTHIA WHITTAKER** both of 19 Pine Road Macclesfield aforesaid
(b) in this Will the expression " my Executors" includes the trustees for the time being of this Will and the trusts arising under it
3. **I GIVE** to the said **WILLIAM OGDEN** my personal chattels as defined by Section 55 of the Administration of Estates Act 1925 to keep such items as he wishes to have and to dispose of the remainder as he sees fit
4. **I GIVE** a legacy of five hundred pounds (£500.00) to each of them **JACK MILVERTON** and **DANIEL MILVERTON** the stepsons of my late son **ANTHONY LAWRENCE DYCHE MILVERTON** if and when they reach eighteen
5. **MY EXECUTORS** shall hold the residue of my estate on trust either to retain or sell it on the following trusts:
 - (a) to pay debts inheritance tax and executorship expenses
 - (b) to divide the residue equally between **LAWRENCE MILVERTON** and **KATIE MILVERTON** the son and daughter of my late son **ANTHONY LAWRENCE DYCHE MILVERTON** as and when they reach eighteen
6. **MY EXECUTORS** shall have the following powers
 - (a) to apply for the benefit of any beneficiary as my Executors think fit the whole or any part of the income from that part of my estate to which he or she is entitled or may in future be entitled
 - (b) to apply for the benefit of any beneficiary as my Executors think fit the whole or any part of the capital to which that beneficiary is entitled or may in future be entitled and on becoming absolutely entitled he or she shall bring into account any payments received under this clause
 - (c) to exercise the Power of Appropriation under Section 41 of the Administration of Estates Act 1925 without obtaining any of the required consents even if one or more of my Executors is beneficially interested

(d) to invest and change investments freely as if they were beneficially entitled
